Registration: All wrestlers must register and pay online at trackwrestling.com by 10:00 pm on Thursday, March 6th. No on-site registration. No morning check-in. Wrestlers must have a current USA card to participate.

Weigh-ins: **REMOTE WEIGH-INS and SKIN CHECKS ONLY.** Must be conducted by a current licensed USAW licensed coach. Email Elisha Haley at haley.elisha@gmail.com to get a team login. Teams will be required to enter in their wrestlers' actual weights by Friday at 12:00 pm. PPWC and/or Head official reserve the right to re-weigh any wrestler at the tournament (2 lb. allowance).

Tournament Format:

- ~ Round Robin – no predetermined weights, wrestlers will be put into groups of 3-5 based upon their actual weights and age division
- ~ Red and blue singlets required for freestyle
- ~ Headgear is optional

Entry: ~ Entry fee for one style is \$30; two styles cost \$40. No refunds. Admission is free.
